AMENDMENT TO SUPPLEMENTARY
DECLARATION OF RESTRICTIONS

Reference is made to the Supplementary Declaration of Restrictions, Onion Creek Section 3, dated February 13, 1978, recorded Book 6087, Page 894, Deed Records of Travis County, Texas, which is incorporated herein by reference and made a part hereof for all purposes.

Connally are the General Partners) hereby declares that paragraph 2., Subdivision, of said Supplementary Declaration of Restrictions refers to the plat of Onion Creek Section 3 as being recorded in Book 3, Page 410, Plat Records of Travis County, Texas, whereas this is the Book and Page of the minutes of the County Commissioner's Court of Travis County in which action on said plat was taken and actually the plat of Onion Creek Section 3 is recorded in Book 75, Page 381, Plat Records of Travis County, Texas, to which plat and its record reference is here made for all purposes. Developer does hereby amend paragraph 2., Subdivision, of the Supplementary Declaration of Restrictions to reflect that the plat of Onion Creek Section 3 is recorded in Book 75, Page 381, Plat Records of Travis County, Texas, and except as amended herein the Supplement shall be applicable to the land described therein.






